All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies S1/S2, B1 and B7 of the London Borough of Camden Replacement Unitary Development Plan 2006.

1 Reasons for granting permission.

You are advised to consult the Council's Environmental Health Service, Camden Town Hall, Argyle Street, WC1H 8EQ (Tel. No. 020 7974 2090 or by email env.health@camden.gov.uk or on the website www.camden.gov.uk/pollution) or seek prior approval under Section 61 of the Act if you anticipate any difficulty in carrying out construction other than within the hours stated above.
- For the avoidance of doubt, and in the light of the annotations on the site location plan, you are advised that this permission does not confer approval for the replacement of any timber windows on either the front or rear elevation of the building with uPVC.

Your attention is drawn to the notes attached to this notice which tell you about your Rights of Appeal and other information.
