- Listed Building Consent is required for any works which involves demolition, or external
  / internal alterations which affect the special historic or architectural interest of a listed
  building, or any structures which fall within its curtilage if these structures were erected
  before 1 July 1948. If you require advice on whether your building is listed or whether
  the works you are proposing require Listed Building Consent, you are advised to
  contact Planning at the address at the end of this application form.
- The Council may need to notify and gain the direction of English Heritage prior to any decision.
- Works which need planning permission will require the submission of a separate application. Advertisement consent will probably be necessary if your proposal involves the display of an illuminated sign and may also be necessary for other types of advertisements. All these applications should be made at the same time.
