Part details of proposed method of ensuring the safety and stability of the building fabric to be retained throughout the period of demolition and reconstruction, pursuant to condition 4 (PART: A, B, C & G only) of listed building consent dated 12/07/06 (2004/3322/L), for the restoration of basement to first floor and parts of second and third floors to hotel use, provision as enabling development of 68 apartments in remaining areas of second and third floors, and at fourth to sixth floor levels, and erection of new wing on Midland Road containing 190 hotel guestrooms at 7 levels. Internal alterations include the removal of partitions, floors and walls, removal and replacement of doors to new openings, insertion of new lift shafts and staircases, and alterations to facilitate the erection of a new West Wing.
