Erection of roof extension (increasing roof pitch, height of roof and creating flat roof area) with dormer window in front roofslope and dormer window with inset terrace in rear roofslope, raising of chimneystacks and installation of 4 rooflights all in connection with existing single-family dwellinghouse (Class C3).

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies S1/S2, B1, B3 and B7 of the London Borough of Camden Replacement Unitary Development Plan 2006.
