On behalf of our client we wish to submit an application for an amendment to the above mentioned permissions.

The previous permissions were both covered by a full fee. This submission is within 1 year of the permission 2006/0966/P and no fee is therefore due. This application is submitted following consultation and advice from Cassie Plumridge, (Ref: CA/2006/ENQ/13327 dated 22nd January 2007).

The application is for a scheme which is essentially the same as the previously approved scheme with the following amendments:

 Relocation of the building by approximately 500m south from the northern boundary. (Current permission approximate average 500mm/proposed 1000mm)

Following the detail development of the construction information, it has become necessary to increase the distance from the boundary to accommodate and allow sufficient tolerance for piling adjacent to the boundary wall. This relocation has also been undertaken on advice from the party wall surveyor.

This amendment was considered material by Cassie Plumridge.

2. Alterations to the east elevation

This alteration is considered to be of a minor nature by Cassie Plumridge and would not require a new application. The alteration has nevertheless been incorporated as an application is being made.

The alteration involves the relocation of a stone panel to achieve a symmetrical arrangement.

In making the application it should be noted that conditions 5 and 7 of the previous permission in regard to hard and soft landscape have been approved and no alteration to the landscape scheme has been made.
