To satisfy Condition No.2 pertaining to the above application reference, I duly enclose the following drawings:

- 230779 – 008S Basement Plan
- 230779 – 020D Basement Doors and Windows Elevations
- 230779 – 045 Basement Doors and Windows details.

The enclosed drawings are in response to the requirements to provide detailed Plan, elevation and section drawings of all new doors and architrave details at 1:1 scale.

To summarise new doors and windows located the Basement are as follows:

- BADO1 and 05 are new fire rated panel timber door.

BADO3 is a new 4 panel timber door which replaces a proposed glass door. This door leading into the shower room will have an architrave profile to one side only, located within the shower room due to the positioning of walls within bedroom which form the wardrobes.

- BA DO6 is a new 4 panel (2 glass, 2 solid) external door.
- BAWO5 is a new 12 pane sash window. To be made by a specialist sub-contractor previously approved drawing 230779-026B.

Regarding both new doors and windows, all details are to match existing profiles found on site.
