Proposal:

Retention of a single storey level rear extension to the existing maisonette as a variation to planning permission dated 08/02/2006 (ref 2005/5508/P) for the erection of a rear conservatory, plus the erection of a balustrade and privacy screen around part of the existing flat roof to facilitate its use as a terrace.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).



2 The area of the terrace shall be restricted to that part of the roof shown on drawing 335/3C hereby approved. The use as a terrace shall not commence until the privacy screen, as shown on the approved drawings, has been constructed. The screen shall be permanently retained and maintained thereafter.

Reason: In order to prevent unreasonable overlooking of neighbouring premises in accordance with the requirements of policies S1/S2 and SD6 of the London Borough of Camden Replacement Unitary Development Plan 2006.

1 Reasons for granting permission.

The proposed development is in general accordance with the policy requirements of the London Borough of Camden Replacement Unitary Development Plan 2006, with particular regard to policies SD6, B1 and B3.
