## Site Description

The application relates to two entrance points to Kenwood House, a Grade I Listed building situated at the northern end of Hampstead Heath and accessed off Hampstead Lane. The application specifically is to place advertisement banners on the boundary fence, which is not a Listed structure and the site is not within any Conservation Area.

#### **Relevant History**

Advert consent (2005/0250/A) granted 25/02/05 for 2 banners on perimeter fence for temporary period of 4 months from 01 May until 01 September 2006. (Temp perm given to ensure adverts are temporary and would not unduly harm the character and appearance of the area).

Advert consent (2004/0765/A) granted 02/04/04 for 2 banners (6m by 1m) on perimeter fence for temporary period of 3 months from 01 June until 01 September 2004. Condition 1 limits period of consent for 3 months.

Appeal allowed 16/07/2004 against condition 1 of 2004/0765/A. Inspector considered 4 month period for advertising banners was unjustified and would compromise the quality of the setting for too long a period but that the 3 months allowed by the Council was insufficient. Inspector amended time limit to allow 4 months from 01 May to 01 September 2004.

Advert consent (2005/4401/A) granted 11/11/05 for 2 banners (3.3m x 1.4m) on perimeter fence for temporary period of 3 weeks from 28 November until 12 December 2005.

#### **Relevant policies**

## Assessment

Temporary Advertisement Consent is sought to display three non-illuminated banners on the perimeter fence of Kenwood House, to advertise Christmas tree sales. The term sought is 29 November 2006 to 22 December 2006.

Applications for display of banners of this kind are made regularly year to promote the annual Kenwood House picnic concerts which take place in July and August and annual Christmas tree sales.

The banners measure 1m x 6m and 3.3m x 1.4m and are fixed to the boundary fences. The display of the banners would not unduly harm the character of the area or nearby Listed Buildings or cause any unreasonable hazard to traffic safety. The temporary nature of the signs is also taken into account and the term sought is considered reasonable.

It is considered that the application is acceptable subject to conditions that should be imposed on any Consent granted.

## Recommendation

Advertisement Consent should be granted subject to conditions.
