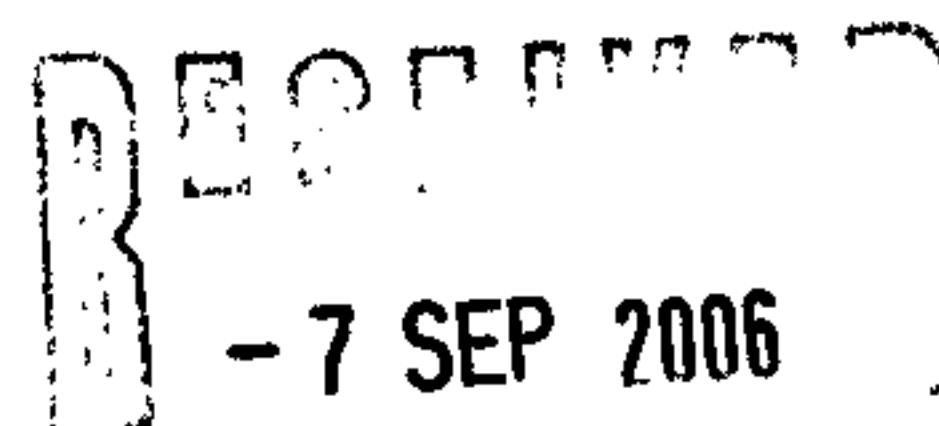

Your letter of 31<sup>st</sup> August and marked up plan faxed through on 6<sup>th</sup> September requests additional information. Taking each of your points in turn:-

## **Sections and elevations inconsistent**

We cannot find any inconsistencies or discrepancies. You also ask for accurate sections and elevations. We have provided you with accurate sections and elevations (accurate at 1:50 to 50mm or so). If you can identify a particular inconsistency or inaccuracy we will deal with it.

## **Greater level of detail**

- A) A section through the wall at the edge of the steps is shown on drawing 15 copies of which you already have.
- B) A section through the handrail at the secondary entrance is shown on drawing 20, five copies of which are enclosed.
- C) Sections at the pavement are shown on drawing 21, five copies of which are enclosed.

- D) Sections through the “top” of the ramp are shown on drawing 22, five copies of which are enclosed.
- E) A full section through the landscaped area is shown on drawing 12, copies of which you already have.

The location of the new details are identified on the revised plan 07A five copies of which are enclosed.

### **Elevations without foliage**

#### **Front**

You already have the existing front elevation without foliage. We have revised the drawing to show the existing sign and handrails. Five copies of drawing 14B are enclosed.

The proposed elevation without foliage is shown on drawing 19, five copies of which are enclosed.

#### **East**

Existing without foliage is shown on drawing 16, five copies of which are enclosed.

Proposed is drawing 09, copies of which you already have.

#### **West**

Existing without foliage is shown on drawing 17, five copies of which are enclosed.

Proposed without foliage is shown on drawing 18, five copies of which are enclosed.

### **Lighting**

Recessed and bollard lights are shown the two enclosed catalogue pages:-


### **Statement**
