# PART APPROVAL / REFUSAL OF WORKS TO TREE/S UNDER A TREE PRESERVATION ORDER

Address: 3 The Mount London NW3 6SZ

Proposal: (TPO Ref: 9H) REAR GARDEN, ALONG REAR BOUNDARY: 3 x Lime - Repollard to existing pollard points at approx. 8m. Remove suckers.

REAR GARDEN, FRONTING HOLLYBUSH STEPS: 1 x Lime - Re-pollard to existing pollard points at approx. 8m. Remove suckers.

The Council has considered your application dated 07 August 2006 and decided the following:

#### a) to REFUSE:

Reducing the height of the trees.

Reasons for Refusal

- 1 It is considered that reducing the height of the trees would have a detrimental effect on their visual amenity and screening value.
- b) to GRANT APPROVAL for:

Reducing the overhang to previous pruning points.



#### Conditions and Reasons:

- This decision is valid for 2 years from the date of this decision or until the work is completed, which ever is the sooner.
  - Reason: To allow the Council to monitor the completion and standards of the work.
- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 1989. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
