DECISION

Town and Country Planning Acts 1990 (as amended)

NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Address: **6 Grove Terrace London NW5 1PH**

Proposed Work:

REAR GARDEN, ALONG RIGHT HAND SIDE BOUNDARY: 1 x Holm Oak - Crown reduce by 25% and shape.

1 x Goat Willow - Fell to ground level and poison stump to prevent regrowth.

REAR GARDEN, ALONG BOUNDARY WITH No.7 GROVE TERRACE: 1 x Privet and 2 x Elder - Fell to ground level and poison stump to prevent regrowth. Grind down stump by up to 250mm below level.

2 x Silver Birch - Remove dead wood and ivy.

REAR GARDEN, LEFT HAND SIDE, CLOSE TO SILVER BIRCH ABOVE: 1 x Lawson Cypress - Fell to ground level. Grind down stump by up to 250mm below ground level.

SIDE GARDEN, ALONG RIGHT HAND SIDE BOUNDARY: 1 x Laburnum and 2 x Hawthorn - Fell to ground level and treat stump to prevent regrowth. Grind down stump to approx. 250mm below ground level.

FRONT GARDEN: 1 x Laburnum - Fell to ground level and treat stump to prevent regrowth. Grind down stump to approx. 250mm below ground level.

FRONT GARDEN, ALONG RIGHT SAND SIDE BOUNDARY: 1 x Ash - Crown reduce by 25% and shape.

1 x Holm Oak - Crown reduce by 25% and shape to lessen weight on right hand side of crown. Lift by 1m.

1 x English Oak - Fell to ground level and poison stump to prevent regrowth. Grind down stump by up to 250mm below ground level.




The Council has considered your notification of intended works to trees dated 22 August 2006 and does not wish to object.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
