Following the grant of Planning Permission for the above application we are now instructed by our clients Mayfair Property Development Ltd. (who are the beneficial owners of this property having acquired the shareholding of Kensington International Ltd.), to make an application for the release of the conditions attached to the consent of the 1st October 2001. A copy of the consent document is attached for your ease of reference.
