DISCONTINUANCE NOTICE

THE COUNCIL OF THE LONDON BOROUGH OF CAMDEN (hereinafter called "the Council") is by virtue of the London Government Act 1963, the Local Planning Authority for the purposes of the Town and Country Planning Act 1990 and the Town and Country (Control of Advertisements) Regulations 1992 in respect of the land described in the First Schedule hereto.

It appears to the Council that, within the meaning of Regulation 8 of the said Regulations, it is necessary in order to remedy a substantial injury to the amenity of the locality to serve this Discontinuance Notice on you.

The Notice is served for the following reason: -

The display of the advertisement panels causes substantial injury to the amenity of the locality. The displays located to the undersides of both railway bridges and bridge walls, east and west side are over scaled and pay no respect to the size and form of the Camden Road Station building, which is statutory Listed Grade II. They collectively are detrimental to the character and appearance of the Station Building, and to the wider street scene, and the Jeffreys Conservation Areas in which they are partly situated.

The site to which this Notice refers is specified in the First Schedule below.

This Notice shall take effect subject to the provisions of Regulation 8 of the said Regulations 8 weeks after service of this Discontinuance Notice.

The Council therefore requires you to take the steps specified in the Second Schedule below within a period of 28 days from the date when the Notice first takes effect.

FIRST SCHEDULE DESCRIPTION OF SITE

Five panels attached to the structures supporting and adjacent to two bridges (ground floor level) serving Camden Road Railway Station, at the junction with Camden Road and Royal College Street, London NW1 which are shown outlined in black for the purposes of identification only on the attached plan and photographs.

SECOND SCHEDULE THE REQUIREMENTS OF THIS NOTICE

Discontinue the display of the 5 advertisements identified in the First Schedule of this Notice for which deemed consent is granted under Regulation 6.


