
- Lighting details for:
 - Slade/South Wing Building Rotunda Rev. * with cable route illustrated.
 - Pearson/Chadwick Side Elevation Rev. * with cable route illustrated.
 - Typical doorway details Rev A
- Diagrammatic illustrations of the cable run to the new lighting scheme, in reference to all main façade's lighting cable run; SK001.

As previously discussed with Victoria on site, all new cable routes to the new light fittings will be concealed, sunk into the ground or in some instances we do utilise the existing cables. For example, for the proposed lighting over the existing doorways, the new proposed cables are fed through from the internal space and direct to the new linear light fittings, which are fixed with conceal fixings through the existing timber door frame. Please refer to the diagrammatic cabling route as enclosed; SK001. We would like to highlight that particular care has been taken in the selection of discrete fittings for accent lighting to the listed features.

I trust that these additional details are sufficient for your approval. Please do not hesitate to contact me, should further information be required.

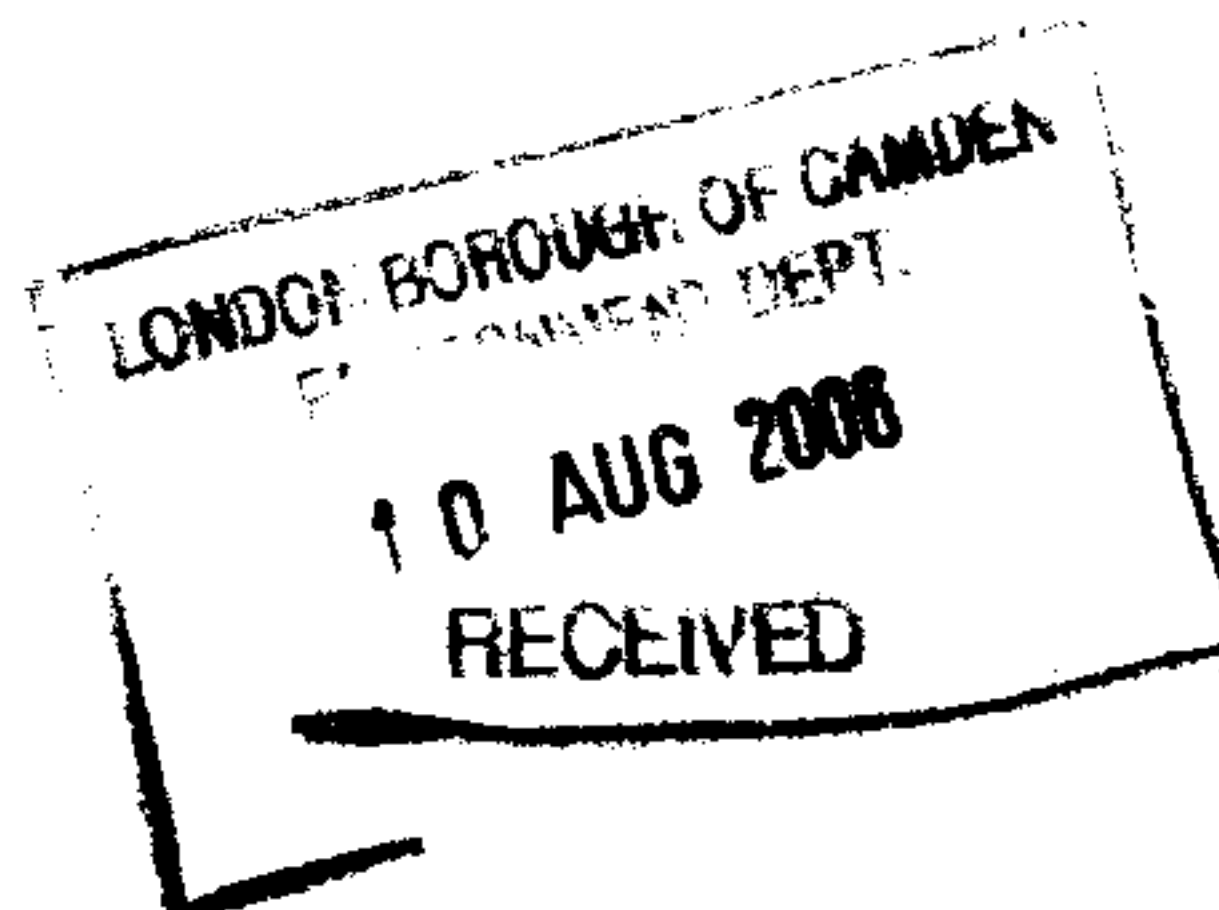
