Further to our letter of 11 October 2005, enclosed are 3 copies of our revised drawing A-00 Revision A (As Existing), as requested. The reason for the delay in resubmitting this information was because the client has been overseas and unfortunately we had no access to the relevant areas during that period.

You will be aware that our client has received an Enforcement Notice (Ref: Legal/RK/1431/288). However, as you have been verbally advised, our client is in agreement with the Planner's recommendations as to the windows (1st floor, front elevation only), the rear terrace and the boundary treatment. This is clearly shown in the drawings already submitted in November 2005. You have requested us only to update the as built drawing as enclosed herewith.
