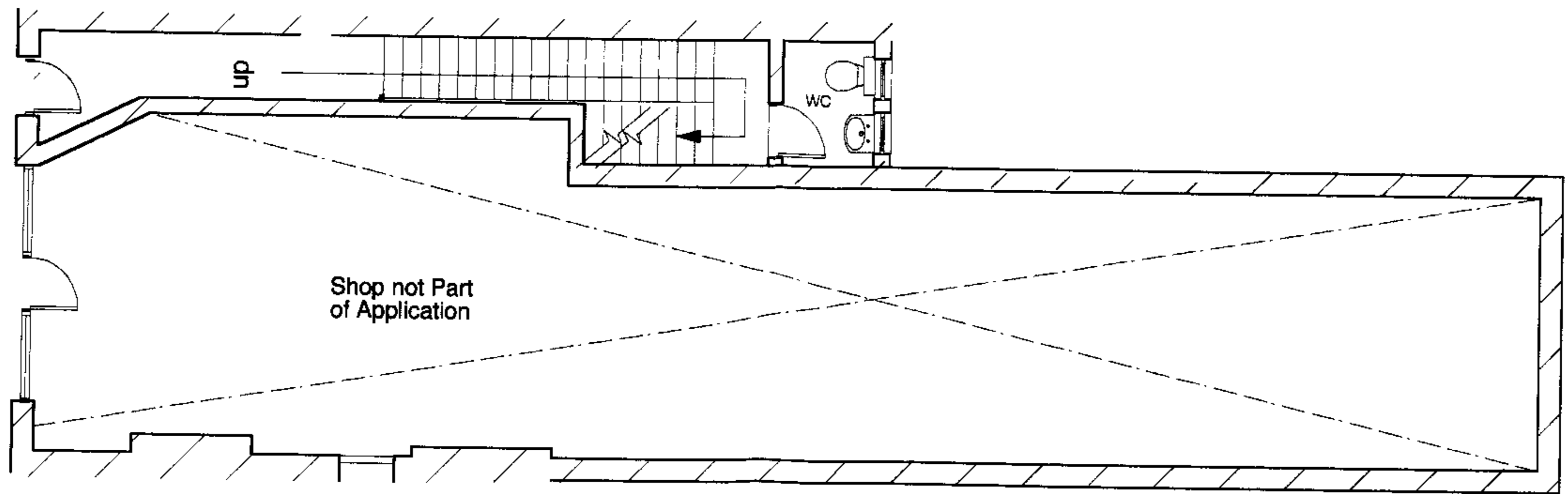
Third Floor Plan



First Floor Plan



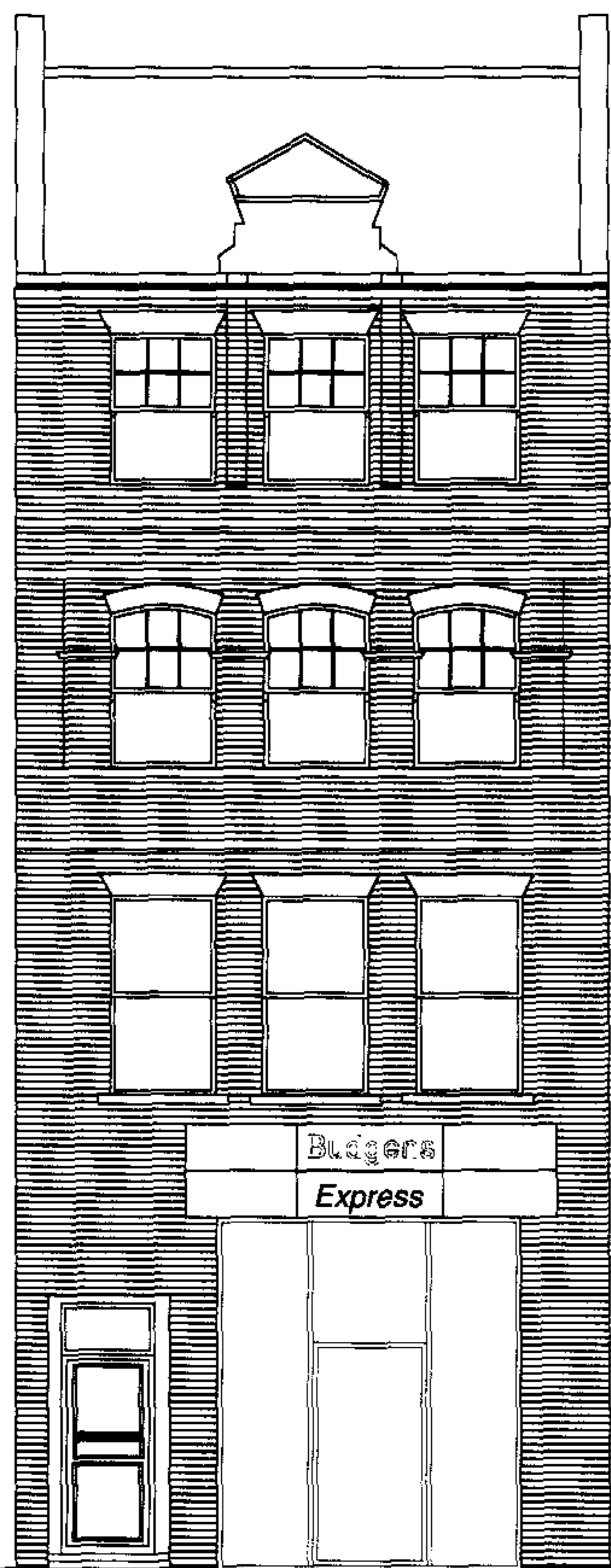
Second Floor Plan



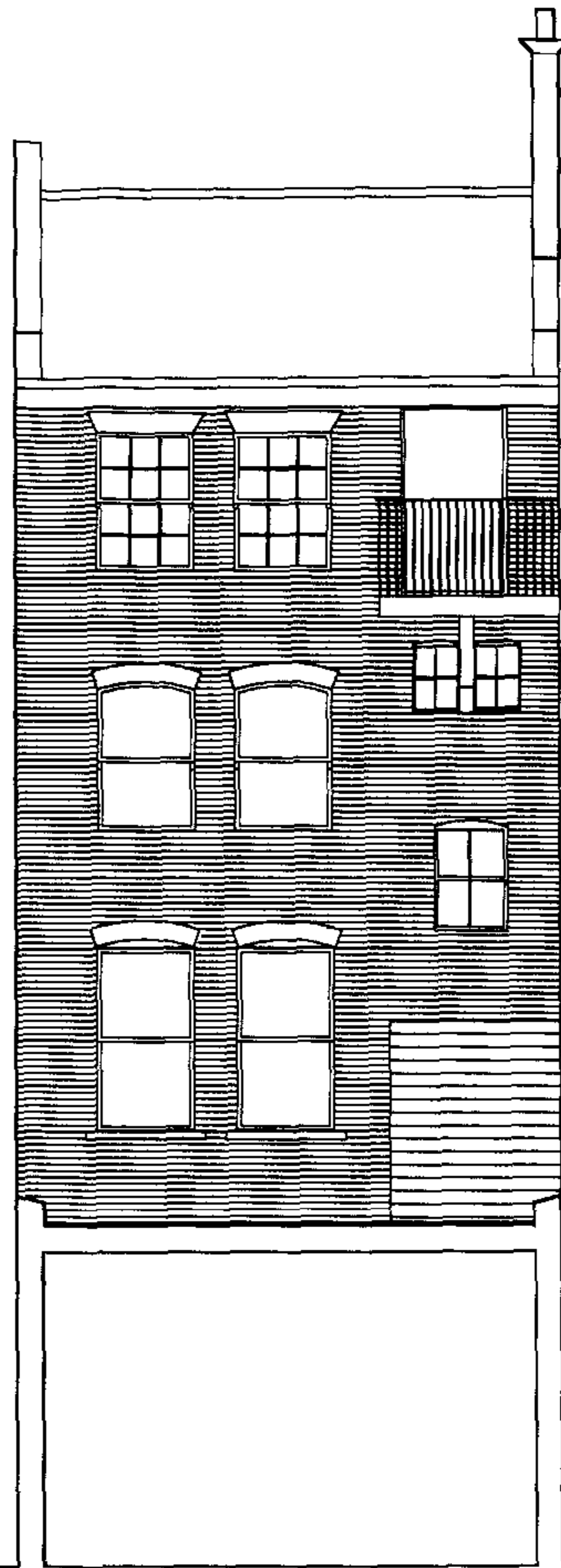

Elevation to Camden High Street

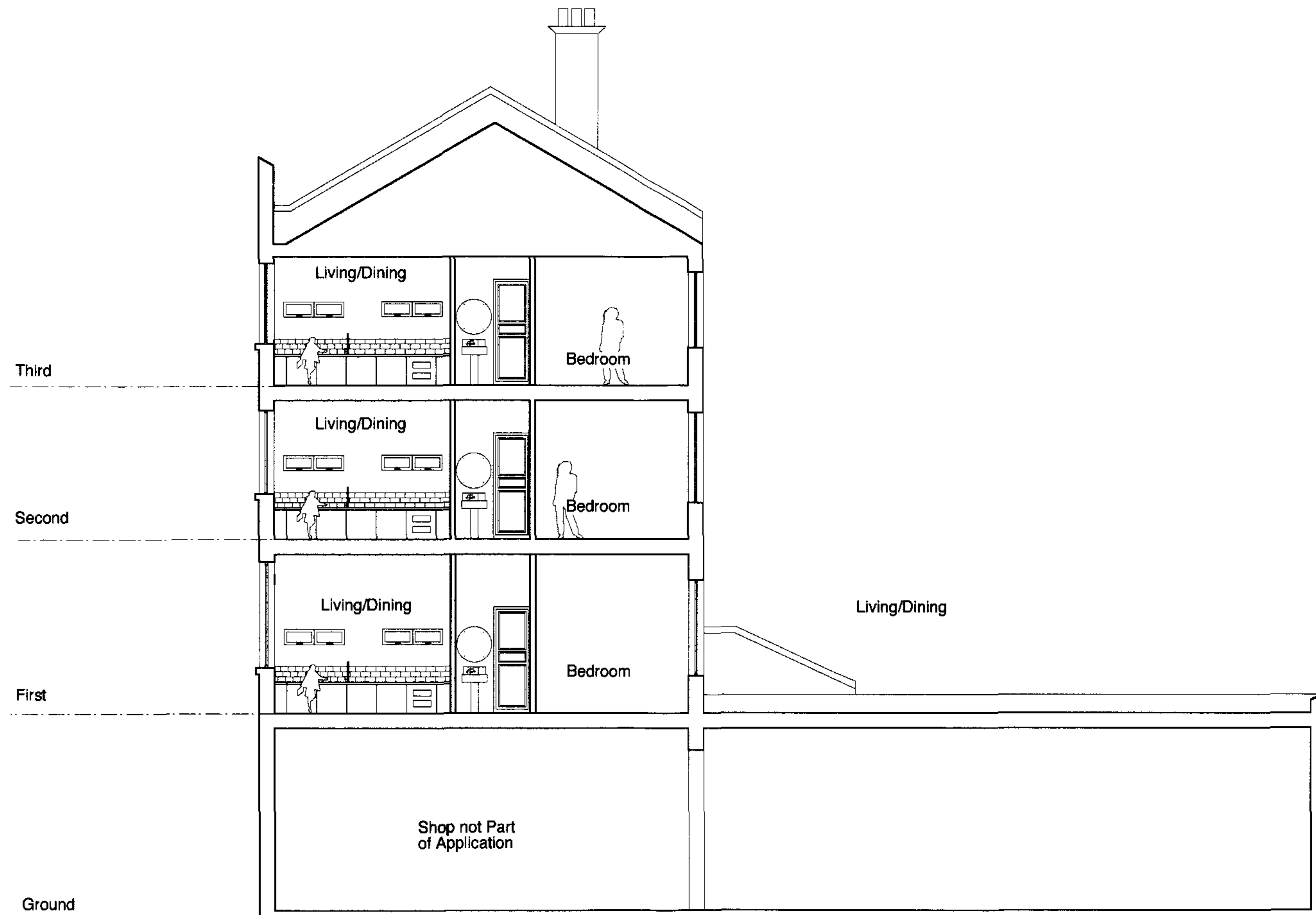
