### Proposal:

Variation to planning permission dated 01.07.02 (PWX0103947) for erection of 3 x 3 storey town houses, in respect of design amendments to the roof, dormer windows, and front and elevations.

The Council has considered your application and decided to grant permission subject to the following condition(s):

## Condition(s) and Reason(s):

The details of the design of the elevations of the 3 new houses at a scale of 1:50, including details of typical elements at a scale of 1:10, shall be submitted to and approved by the Council before work on this aspect of the scheme is commenced, and the scheme shall be completed in full accordance with the approved details. Note that the detailing of the front parapet wall is also reserved by this



condition and details of the junction between the proposed houses and 77 Belsize Lane shall be submitted at a scale of 1:10.

Reason: To ensure that the Council may be satisfied with the external appearance of the building in accordance with the requirements of policies EN1,EN13,EN31 of the London Borough of Camden Unitary Development Plan 2000

# Informative(s):

- Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. You are advised to consult the Council's Building Control Service, Camden Town Hall, Argyle Street WC1H 8EQ, (tel: 020-7974 6941).
- Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. The penalty for contractors undertaking noisy works outside permitted hours is a maximum fine of £5000 per offence. You are advised to consult the Council's Environmental Health Division, Camden Town Hall, Argyle Street, WC1H (Tel. No. 020 7974 4444) or seek prior approval under Section 61 of the Act if you anticipate any difficulty in carrying out construction other than within the hours stated above.
- You are reminded of the need to satisfy the requirements of the remaining outstanding conditions on planning permission dated 1/07/02 (ref.PWX0103947R1)
