- 2 The proposed extension is considered to be visually detrimental to the character and appearance of the building, the listed entrance gates and listed garden walls of which it forms part, the surrounding listed buildings and the Highgate Village Conservation Area as referred to in Policies EN1, EN13, EN14, EN31 and EN38 of the London Borough of Camden Unitary Development Plan 2000, Section 2.8 of the London Borough of Camden Supplementary Planning Guidance 2002 and the Highgate Conservation Area Statement (Draft) 2002.

- 2 It is considered that, in principle, an additional storey in the form of a roof extension is not acceptable.
