

Re: Planning Application at the St. Richard of Chichester School, 40 Prince of Wales Road, NW5 3LN

Further to our meeting at your offices on the 20th September 2001 and your subsequent telephone discussions with Yvonne Phillips at PPS, the amendments to the submitted scheme are as follows:

- 1. It is proposed to delete the new build element from the scheme (Units M11, M12, M22, M23 & M32) and increase the level of communal amenity space by creating a new communal area on the site of the new build. All dividing walls in the garden areas have been removed.
- 2. The deletion of the new build will reduce the number of dwellings in the scheme from 35 to 30. This now equates to 7 affordable homes and 23 private dwellings. The proportion of affordable units is therefore approximately 25%.
- 3. Units C19, C25 and C26 in the listed building are now proposed to be for affordable dwellings.
- 4. In terms of type of accommodation, it is proposed to provide 10 x 3 bed, 9 x 2 bed and 4 x 1 bed private units and 3 x 3 bed, 1 x 2 bed and 3 x 1 bed affordable units.
- 5. The large dormer structure to Units C28 and C29 has been reduced to two small single dormers, which are essentially the same as the previous scheme.
- 6. A pedestrian entrance/emergency exit has also been placed at the rear of the underground car park.
