**ENFORCEMENT NOTICE "B" RE: \* 33 GRESSE STREET, LONDON W1P 1PN** 

#### ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations.

#### 2. THE LAND AFFECTED.

**33 GRESSE STREET, LONDON W1P 1PN** Land and premises at ("the Premises"). The Premises are shown, for the purposes of identification only, outlined in black on the attached plan.

## 3. THE BREACH OF PLANNING CONTROL ALLEGED.

Without Planning Permission:

The unauthorised installation of two air conditioning condenser units on the rear elevation. These are located on the eastern end of the building at first floor level, above a double door fire exit into Percy Mews.

# 4. REASONS FOR ISSUING THIS NOTICE

a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.

b) The two air conditioning condenser units are considered to be unacceptable in the interests of visual amenity. More particularly the units, by reason of their location, design and general appearance are considered to be discordant and obtrusive, causing harm to the appearance of the property, the street scene and the conservation area. In this respect they are contrary to Policy EN33 of the London Borough of Camden Unitary Development Plan.

The Council do not consider that planning permission should be given, because planning conditions could not overcome these problems.

#### 5. WHAT YOU ARE REQUIRED TO DO.

The two air conditioning condenser units on the rear elevation of the eastern end of the building, at first floor level, above a double door fire exit into Percy Mews, shall be permanently removed, together with any brackets or other structures supporting them. The rear elevation shall then be made good.

You are to comply with the above requirements within **2 months** of this notice taking effect.

## 6. WHEN THIS NOTICE TAKES EFFECT.

This notice takes effect on **7** day of **September 2000** unless an appeal is made against it beforehand.

(a) One is for you to send to the Secretary of State if you decide to appeal, together with a copy of this enforcement notice.


(b) Send the second copy of the appeal form and notice to the Council at:

Failure to comply with an enforcement notice, which has taken effect, can result in prosecution and/or remedial action by the Council.
