- 2 All hard and soft landscaping works shall be carried out to a reasonable standard in accordance with the approved landscape details, by not later than the end of the planting season following completion of the development or any phase of the development, whichever is the sooner. Any trees or areas of planting which, within a period of 5 years from the completion of the development, die, are removed or become seriously damaged or diseased, shall be replaced as soon as is reasonably possible and, in any case, by not later than the end of the following planting season, with others of similar size and species, unless the Council gives written consent to any variation.
- 3 The approved joinery to the extension hereby approved shall be constructed in stained timber.
- 4 The development shall be constructed in strict accordance with the drawings hereby approved or drawing which are subsequently approved pursuant to conditions which are attached to this planning permission.

Reasons for additional conditions:

- 1 To ensure that the Council may be satisfied with the external appearance of the building.
- 2 To ensure that the landscaping is carried out within a reasonable period and to maintain a satisfactory standard of visual amenity in the scheme.
- 3 The Council considers that timber doors would be more in keeping with the character of the building than metal doors as shown on the approved drawings.
- 4 To safeguard the appearance of the premises and the character of the immediate area.
