- All new works, and works of making good to the retained fabric, whether internal or external, shall be finished to match the adjacent work with regard to the methods used and to material, colour, texture and profile and, in the case of brickwork, facebond and pointing.
- Detailed drawings, or samples of materials, as appropriate, in respect of the following shall be submitted to and approved by the Council before the relevant part of the work is begun:
 - a. all new joinery;
 - b. upgrading of existing doors for fire purposes;
 - c. all structural repairs and levelling of floors;
 - d. reinstated cornice to street elevation.
- Existing historic doors are to be retained and upgraded for fire purposes, if necessary.

Reasons for additional conditions:

1-4 In order to safeguard the special architectural and historic interest of the building.
