Standard Condition:

1. The works hereby permitted shall be begun not later than the expiration of five years from the date on which this consent is granted.

Reason for Standard Condition:

1. In order to comply with the provisions of Section 18 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

Additional Condition(s):

01 No work shall start on site without prior written notification of that start to The London Division of the Historic Buildings and Monuments Commission, Chesham House, 30 Warwick Street, London WlR 6AB, quoting date 30.07.93 and reference LD4351.

02 That all new works, and works of making good to the retained fabric, whether internal or external, shall be finished to match the adjacent work with regard to the methods used and to material, colour, texture and profile.

03 The new rooflight shall be of traditional cast iron construction.

04 Detailed drawings or samples of materials, as appropriate, in respect of of the following, shall be submitted to and approved by the Council before the relevant part of the work is begun: (a) all new external joinery.

Reason(s) for Additional Condition(s):

01 As required by The Historic Buildings and Monuments Commission.
02 - 04 In order to safeguard the special architectural or historic interest of the building.
