'ermission for development on an outline application (conditional)

he Council in pursuance of its powers under the above-mentioned Acts and Orders made thereunder, hereby grants permission on an outline application for development referred to in the undermentioned Schedule, subject to the conditions set out therein.

This permission is given subject to the time limit condition imposed by the Town and Country Planning Act 1966.

It is also subject to due compliance with the local Acts, regulations, building bye laws and general statutory provisions in force in the area and nothing herein shall be regarded as dispensing with such compliance or be deemed to be a consent by the Council thereunder.

Your particular attention is drawn (a) to the provisions of the London Building Acts 1930-39 and the byelaws in force thereunder which must be complied with to the satisfaction of the District Surveyor whose address may be obtained from this office and (b) to the Statement of Applicant's Rights set out overleaf.

I would also remind you that the Council's permission does not modify or affect any personal or restrictive covenants, easements, etc., applying to or affecting either this land or any other land or the rights of any persons (including the London Borough of Camden) entitled to the benefit thereof or holding an interest in the property concerned in this development or in any adjoining property.

## Conditions:

## Statement of Applicant's Rights arising from the grant of permission subject to conditions

If the applicant is aggrieved by the decision of the local planning authority to grant permission or approval bject to conditions, he may appeal to and on a form obtainable from the Minister for Local Government and velopment, Department of the Environment, Whitehall, London, SW1, in accordance with section 23 of the own and Country Planning Act 1962, within six months of receipt of this notice. The Minister has power to allow a longer period for the giving of a notice of appeal but he will not normally be prepared to exercise this power unless there are special circumstances which excuse the delay in giving notice of appeal. The Minister is not required to entertain an appeal if it appears to him that permission for the proposed development could not have been so granted otherwise than subject to the conditions imposed by the local planning authority having regard to the statutory requirements, to the provisions of the development order, and to any directions given under the order. (The statutory requirements include section 6 of the Control of Office and Industrial Development Act 1965 and section 23 of the Industrial Development Act 1966.)

(2) If permission to develop land is granted subject to conditions, whether by the local planning authority or by the Minister, and the owner of the land claims that the land has become incapable of reasonably beneficial use in its existing state and cannot be rendered capable of reasonably beneficial use by the carrying out of any evelopment which has been or would be permitted, he may serve on the Common Council, or on the Council of e county borough, London borough or county district in which the land is situated, as the case may be, a base notice requiring that council to purchase his interests in the land in accordance with the provisions of If the Town and Country Planning Act 1962 (as amended by the Town and Country Planning Act 1968).
