(1) If the applicant is aggrieved by the decision of the local planning authority to grant permission or approval subject to conditions, he may appeal to and on a form obtainable from the Minister for Local Government and Development, Department of the Environment, Whitehall, London, SW1, in accordance with section 23 of the Town and Country Planning Act 1962, within six months of receipt of this notice. The Minister has power to a longer period for the giving of a notice of appeal but he will not normally be prepared to exercise this wer unless there are special circumstances which excuse the delay in giving notice of appeal. The Minister of required to entertain an appeal if it appears to him that permission for the proposed development could ave been so granted otherwise than subject to the conditions imposed by the local planning authority regard to the statutory requirements, to the provisions of the development order, and to any directions der the order.
