- (1) On the 18th day of January 1982 the Council of the London Borough of Camden (hereinafter called "~~the local planning authority~~" <sup>Council</sup>) being the ~~appropriate local planning authority~~ <sup>for the area</sup> and in pursuance of their powers under the Town and Country Planning Act 1971 and the Town and Country Planning (Listed Buildings and Buildings in Conservation Areas) Regulations 1977, granted a listed building consent <sup>reference No. N.3/10/C/HB2751(R1)</sup> (hereinafter called "the listed building consent") to Messrs. Lambiel Associates, Architects of 1 Ailsop Place, London, NW1, ~~in respect of the proposed situate at 35/37 Windmill Street, London, W.1. For the demolition of buildings at 35/37 Windmill Street, London W.1, being unlisted buildings in a conservation area, more particularly delineated in the plan annexed hereto and thereon edged red.~~
- (2) A copy of the listed building consent is annexed hereto and marked "Appendix A".
- (3) The works referred to in the listed building consent have not been completed.
- (4) It appears to the ~~local planning authority~~ <sup>Council</sup> that it is expedient, having regard to the development plan and all other material considerations, that the listed building consent should be revoked in the manner hereinafter appearing.

NOW THEREFORE the ~~said Council in its capacity of local planning authority and in pursuance of Part II of Schedule 11 of the Town and Country Planning Act 1971 and of all other powers enabling hereby makes the following Order as follows:-~~ <sup>of the powers conferred in Paragraph 10 of the said Schedule 11</sup>

1. The listed building consent is revoked.
2. This Order may be cited as "The London Borough of Camden Revocation of Listed Building Consent Order No. 2/1982."
