Description:

The tree is a mature self-seeded Sycamore which has historically been pollarded to contain its crown size and minimise its significant encroachment to the many properties in close proximity. The tree is growing in a very restricted site with limited nutrient availability and soil root zone, and is showing some signs of stress in its lower foliage. The tree is directly adjacent to an old wall that is extensively fractured as a direct result of the trees incremental growth; this damage cannot realistically be repaired whilst the tree remains.
