1 The development hereby permitted shall be carried out in accordance with the following approved plans [Location plan; 320/1; Design & Access Statement ref. MB/DT/13/213.

Reason: For the avoidance of doubt and in the interest of proper planning.

2 No music shall be played on the premises in such a way as to be audible within any adjoining premises or on the adjoining highway.

Reason: To safeguard the amenities of the adjoining premises and the area generally in accordance with the requirements of policies CS5 of the London Borough of Camden Local Development Framework Core Strategy and policy DP26 of the London Borough of

3 The use hereby permitted shall not be carried out outside the following times: 08:00 hours - 22:00 hours Mondays to Saturdays; unless with the prior written consent of the local planning authority. No customers shall be on the premises and no sound emanating from these premises shall be audible within any adjoining premises outside of these hours.

Reason: To safeguard the amenities of the adjoining premises and the area generally in accordance with the requirements of policies CS5 of the London Borough of Camden Local Development Framework Core Strategy and policy DP26 of the London Borough of Camden Local Development Framework Development Policies.
