E.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with 1 standard ash in the same place.

Prune horsechestnut T1 locat4ed at the front of property. Clean to remove all dead diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure. Remove lower branches to a height of 6 - 6.5 metres to improve clearance over road. Thin crown to remove approx 15% of live branches to improve light and air penetration through crown. Most thinning cuts will be between 1 and 3 centimeters in diameter. Reduce crown height and spread by approximate 1 - 2 metres to enchance natural form.
