- 1.6 Linkages and RoutesThe Site is crossed by the Metropolitan Walk City Walk 1 (between the Mixed Bathing Pond and Hampstead No.2 Pond). The Site is not part of the transport network, however there is an extensive path network across The Site and a number of designated cycleways:
 - between the Mixed Bathing Pond and Hampstead No.2 Pond;
 - crossing the Viaduct; and
 - between Model Boating Pond and Men's Bathing Pond.
- 1.7 There is one horse riding route (for permit holders) crossing The Site between Bird Sanctuary Pond and Model Boating Pond.
- 1.8 Within the study area there is an extensive path network across The Heath.
- 1.9 The locations of these PRoW are illustrated on Figure 6.2. For the assessment of effects on users of the linkages and routes, refer to the Community chapter.

Existing Vegetation

- 1.10 The vegetation within The Site includes mature individual trees, areas of woodland, scrub and reeds associated with the aquatic environment. The most notable areas of vegetation are Veteran English Oak trees at Stock Pond and at the Viaduct, Black Poplars at the Catchpit and London Planes at Hampstead No.2 Pond and along Cathedral Walk. With reference to the Arboricultural Implications Report (AIR) the vegetation at each of the ponds is summarised as:
 - Stock Pond predominantly English Oaks along the southern boundary of the pond and English Oak, common Alder and groups of Hornbeam to the south of the path network. The two most notable trees (category A) are located to the east of the pond and English Oaks;
 - Kenwood Ladies' Bathing Pond includes common Alder, English Oak and Silver Birch on the southern edge of the pond and towards the Bird Sanctuary Pond;
 - The Bird Sanctuary Pond includes common Alder, English Oak and willows bordering the southern edge
 of the pond;
 - Model Boating Pond Lime and False Acacia at the location of the proposed island, with Hornbeams, Ash and London Plane along the southern boundary;
 - Men's Bathing Pond includes Willows, Hornbeams and English Oak to the south of the pond. There are two category A trees;

- Highgate No.1 Pond includes English Oak, Sycamore, Hawthorn and Willow along the southern edge and Sycamore, Ash and Oak along the eastern edge;
- Viaduct Pond includes English Oak and Willows, with one category A English Oak tree along the southern edge of the pond;
- Vale of Health Pond includes English Oaks, Silver Birch, Hawthorn and sycamores along the eastern edge of the pond;
- Catchpit include English Oak, wet woodland mixes, Hybrid Black Poplars and Willows. There are five category A trees;
- Mixed Bathing Pond includes English Oaks along the western edge;
- Hampstead No.2 Pond includes hawthorn and Hybrid Black Poplar along the northern embankment forming the raised path with Mixed Bathing and a category A row of London Plane trees along the southern edge; and
- Hampstead No.1 Pond includes a row of category A London Plane trees to the west of the pond.
- 1.11 Within the study area there are numerous areas of vegetation, including open grassland and individual veteran trees within Hampstead Heath, individual mature trees and ancient woodland within the landscaped grounds at Kenwood House, formal avenues along Lime Walk and bordering the road networks and individual garden planting.

Visual Baseline

1.12 The zone of theoretical visual influence (ZTV) extends across Hampstead Heath to include recreational users within The Heath and adjacent residences in Hampstead and Highgate. This is due to The Sites relative low lying position within The Heath, the proximity of residences, views from elevated locations at Parliament Hill and close range views from the path network and fields within The Heath. There are no locations from which all aspects of The Site are visible due to the undulating landform and the vegetation coverage within The Heath and there is also no inter-visibility between the Hampstead and Highgate chain of ponds. The intervisibility between the individual ponds is also limited due to the undulating landform and vegetation coverage, with views of the ponds being restricted to localised visual envelopes as follows:

Highgate Chain

Stock Pond – the visual envelope is limited by the rising landform adjacent the pond, so that views of the pond are predominantly from close range and the adjacent path network;

- Kenwood Ladies' Bathing Pond the visual envelope is limited by the mature vegetation bordering the pond and the undulating landform to the west;
- The Bird Sanctuary Pond the visual envelope extends southwards across The Heath due to the proximity of the path network. The visual envelope is limited in other directions by the rising landform and vegetation;
- The Model Boating Pond the visual envelope extends east to properties in Highate and west across The Heath. This is due to the rising landform around the pond and the more open character of the surrounding fields;
- The Mens Bathing Pond the visual envelope is limited by the surrounding vegetation, rising landform to the north and falling landform to the south; and
- Highgate No.1 Pond the visual envelope extends westwards to Parliament Hill and southwards across
 The Heath due to the open character of the fields. To the north and east the visual envelope is limited by
 the vegetation and rising landform.

Hampstead Chain

- Viaduct Pond the visual envelope is limited by the rising landform and vegetation surrounding the pond;
- Vale of Health Pond the visual envelope is limited by the close proximity of properties to the west of the pond, the landform and the extent of surrounding vegetation;
- Catchpit the visual envelope is limited due to the sunken position within the landform and the extent of vegetation;
- Mixed Bathing Pond the visual envelope is limited by the adjacent vegetation and rising landform to the north, east and west;
- Hampstead No.2 Pond the visual envelope extends to properties in South Hill Park Road and The Heath
 to the west. The visual envelope to the north and south is restricted by the rising landform and
 vegetation; and
- Hampstead No.1 Pond the visual envelope is limited by the properties to the east and vegetation to the north and south.

Borrow Pits

- Fields (Sports Ground) the visual envelope is limited by the rising landform to the north and adjacent vegetation;
- Fields (south of Pryors Field) the visual envelope is limited by mature vegetation along the path network and the rising landform across Pryors Field;

- Fields (adjacent Model Boating) the visual envelope is limited by the rising landform across the Heath;
 and
- Fields (west of Model Boating) the visual envelope is limited by the rising landform across the Heath.

Designated / Identified Views

- 1.13 There are two designated views within Hampstead Heath within the London View Management Framework:
 - View 2 from Parliament Hill, looking south across London (2A.1 and 2B.1); and
 - View 3 from Kenwood Gazebo, looking south across The Heath to London (3A.1).
- 1.14 View 2 is scoped out of the assessment as the angle of view is towards London and the Proposed Development is not within the same field of view.
- 1.15 There are a number of selected outstanding views (this is the term illustrated on the Hampstead Heath map) within Hampstead Heath:
 - Parliament Hill, looking south across London;
 - east of the Tumulus, looking east across The Heath towards Highgate; and
 - Kenwood gazebo, looking south across The Heath to London.
- 1.16 The designated and selected outstanding view from Parliament Hill is scoped out of the assessment as the direction of the view is towards London and the Proposed Development is not within the same field of view.
- 1.17 There are a number of distinctive outward and inward views identified by The Heath and Hampstead Society, with those relevant to the Proposed Development as:
 - from the Viaduct to Christchurch steeple; and
 - Parliament Hill to Christchurch steeple.

Identified Visual Receptors

1.18 The following table lists the identified visual receptors within the study area, relevant to the Proposed Development. These are illustrated on Figure 6.5
