- #3 ) Large Sycamore spread reduce 15% and blend (property side only) + 6 meter lift - severe encroachment over lawn towards property.
- #4) Small Cherry (dead) Fell - Dead in border with neighbouring fence line. crowded out by surrounding trees.
- #5) Small pear reduce 15% - poor pruning cuts and snapped out limbs need addressing.
- #6) Small sycamore reduce 15% - poor pruning cuts and snapped out limbs need addressing.
- #7) Group of Small Elders, dead wood/sever ivy - promote longevity.
