Site Description

The site comprises a large secondary school consisting of numerous blocks. It is bounded by Churchill Road, Dartmouth Park Hill, Burghley Road and Burghley Court.

The site is not listed and is not within a Conservation Area, but is adjacent to the Dartmouth Park Conservation Area.

Assessment

Proposal: Permission is sought for the installation of a temporary classroom at the north west part of the site for a temporary period until 31st August 2014

Assessment: The proposed classroom would measure approx. 12.3m in width x 10.2m in depth x 3.2m in height.

It would appear as portacabin type structure of a temporary nature and would only be in place until August/September 2014 whilst major works are carried out at the school.

The classroom would be located to the north eastern part of the site adjacent to an existing staff car park on a games/sports area. Churchill Road runs directly north of the site location, however the classroom would be shielded from view by a high wall and railings, so would not be visible from the street.

As the proposed structure would clearly read a temporary addition and is necessary to allow the school to operate whilst construction works are taking place until September 2014, and that they are located well within the site; is not overly visible from the street or surrounding properties and will not cause any amenity issues it is considered to be acceptable.

Recommendation: Grant Planning Permission
