E.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with 1 standard ash in the same place.

Front Garden:

T1: Cherry: Approximately 5.5m. This tree has some evidence of poor pruning works in the past. Judiciously reduce extraneous branches back into main crown structure, thin crown density 20%, carry out remedial pruning works to remaining stub cuts. Remove dead wood.

T2 & T3: Holly: Approximately 8m, located rear of lawn. Reduce crown by means of reducing extraneous growth back into main crown structure in order to help manage at reasonable dimensions for the garden to increase light levels.

T4: Yew: Approximately 9m. This tree is covered by rambling rose and has merit for its natural characteristics. Judiciously reduce exposed crown by 15% and reduce extraneous and wayward rose branches back into crown shape in order to tidy and control.

T5: Elder: Approximately 7m. Remove dead wood and broken branches only.

Rear Garden of Hampstead Hill Mansions, Downshire Hill:

T6: Ash: Approximately 17m. This fast growing tree is now the major shade contributor to the rear property. There is certainly scope for height reduction without substantially compromising screen. Reduce height by approximately 30-35%, thin crown density by 20% and remove dead wood. Reason - to open 7 Hampstead Hill Gardens to more sky whilst preserving screening form the building.

T7: Holly: Approximately 12m. Reduce height by approximately 20-30%.

T8: Cherry: Approximately 17m. Reduce height by approximately 20-25%. Thin higher reaches of crown by approximately 15% and remove dead wood.

T9: Large Cherry: Approximately 18m. We do not wish to greatly reduce the height of this veteran tree. Reduce height by 15-20%, thin crown density by 15-20% and remove dead wood.

Sycamore: Located in 49 Downshire Hill. Remove one low branch overhanging 7 Hampstead Hill Gardens. Branch is approximately 15cm diameter at union with main stem. Reasons – Our specification has been produced with the aims of increasing light levels to surrounding properties whilst maintaining screening effects of trees. Along with general maintenance considerations and hazard management the pruning techniques we employ will ensure that tree health, natural characteristics and aesthetic value are preserved. Our balanced and considered approach to tree management also helps ensure that re-growth is moderate.
