### **ENFORCEMENT NOTICE**

OF 6 Princess Road London NW1 8JJ

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

#### 2. THE LAND AFFECTED

Land at: 6 Princess Road, London NW1 8JJ

as shown, for the purposes of identification only, outlined in black on the attached plan.

### 3. THE BREACH OF PLANNING CONTROL ALLEGED

**Without Planning Permission:** the unauthorised erection of timber decking, posts and railings facilitating the use of the flat roof on the top of the second floor rear extension as a roof terrace.

### 4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The unauthorised erection of the timber deck, posts and railings is considered harmful to the character and appearance of the Primrose Hill Conservation Area, contrary to policies CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 (Securing high quality design) and DP25 (Conserving Camden's

heritage) of the London Borough of Camden Local Development Framework Development Policies 2010.

c) The unauthorised erection of the timber deck, posts and railings are considered harmful to the amenity of the neighbouring residential properties contrary to policy CS5 (Managing the impact of growth and development) and of the London Borough of Camden Local Development Framework Core Strategy and policy DP26 (Managing the impact of development on occupiers and neighbours) of the London Borough of Camden Local Development Framework Development Policies 2010.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

#### 5. WHAT YOU ARE REQUIRED TO DO

Within a period of **one month** of the Notice taking effect: the unauthorised timber deck, posts and railings shall be removed from the second floor flat roof on the extension at the rear of the property.

#### 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 11 March 2014 unless an appeal is made against it beforehand.
