ENFORCEMENT NOTICE

OF 20 Belsize Park London NW3 4DU

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information

2. THE LAND AFFECTED

Land at: 20 Belsize Park, London NW3 4DU as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: Removal of original metal balcony and balustrade and replacement with raised ground floor timber balcony with metal railings and timber staircase

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The balcony by reason of its size, position and detailed design is considered to be unacceptable and is therefore considered to detract from the character and appearance of the host building and conservation area and is thereby contrary to policies CS14, DP24 and DP25 of the London Borough of Camden Local Development Framework.

Council reference: EN13/0629

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of **6 months** from the Notice taking effect:

- (a) Remove the existing unauthorised structure and associated staircase at rear upper ground floor level; and
- (b) Reinstate the balcony to match the original balcony as closely as possible in terms of its size, position and detailed design

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **4 June 2014** unless an appeal is made against it beforehand.
