ENFORCEMENT NOTICE

OF 78 Queen's Crescent London NW5 4EB

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: 78 Queen's Crescent, London NW5 4EB as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: Installation of timber structure on forecourt of retail unit without planning permission.

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The unauthorised works are considered to have a detrimental impact on the character and appearance of the townscape and therefore contrary to CS5 (Managing the impact of growth and development), CS14 (Promoting high quality places) & CS17 (Making Camden a safer place) of the London Borough of Camden Local Development Framework Core Strategy and policies DP30 (shop fronts) and DP24 Securing high quality design of the local development framework.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of 14 days of the Notice taking effect:

- 1. Completely remove the timber structure from forecourt; and
- 2. Make good any damage to building or pavement.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 16 May 2014 unless an appeal is made against it beforehand.

WHAT HAPPENS IF YOU DO NOT APPEAL


