#### LISTED BUILDING ENFORCEMENT NOTICE

OF Flat 4 (ground floor) 55 Fitzjohn's Avenue London NW3 6PH

1. **THIS IS A FORMAL NOTICE**, which is issued by the Council being the Local Planning Authority for the purposes of Section 38 of the above Act because it appears to them that there has been a contravention of Section 8 of the Act, in respect of the building within a conservation area described below. The Council considers it necessary to issue this notice for the reasons set out in paragraph 4 below.

#### 2. THE LISTED BUILDING.

Land at: Flat 4 (ground floor), 55 Fitzjohn's Avenue, London NW3 6PH as shown, for the purposes of identification only, outlined in black on the attached plan.

#### 3. THE CONTRAVENTION ALLEGED.

**Without listed building consent**: The unauthorised fitting of partitioning within the ground floor main hallway which forms a room in the northern end of this space.

#### 4. REASONS FOR ISSUING THIS NOTICE

- 1. The work outlined above has been carried out to this Grade II listed building without the benefit of Listed Building Consent.
- 2. The unauthorised works to the central ground floor hallway of this property are considered to have a detrimental impact on the special architectural and historic interest of the listed building, therefore contrary to policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

### 5. WHAT YOU ARE REQUIRED TO DO

Within two months of the Notice taking effect:

- 1. remove the unauthorised partitioning from the ground floor hallway of the property; and
- 2. make good any damage to the original fabric of the building, matching the materials found adjacent to the damage as appropriate

#### 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **15 May 2014**, unless an appeal is made against it beforehand.
