1. **THIS IS A FORMAL NOTICE**, which is issued by the Council being the Local Planning Authority for the purposes of Section 38 of the above Act because it appears to them that there has been a contravention of Section 8 of the Act, in respect of the building within a conservation area described below. The Council considers it necessary to issue this notice for the reasons set out in paragraph 4 below.

2. THE LISTED BUILDING.

Land at: 13 Chalcot Square, London NW1 8YA

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE CONTRAVENTION ALLEGED.

Without listed building consent:

- 1) The unauthorised installation of double glazed windows at first floor level of the front elevation; and
- 2) The removal and replacement of the secondary staircase

4. REASONS FOR ISSUING THIS NOTICE

- 1) The work outlined above has been carried out to this Grade II listed building without the benefit of listed building consent.
- 2) The unauthorised works to both the front elevation and internally to this property are considered to have a detrimental impact on the special architectural and historic interest of the listed building, and the listed terrace and therefore contrary to policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 (Conserving Camden's heritage) of the London

Borough of Camden Local Development Framework Development Policies.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of two months of the Notice taking effect:

- 1) Remove the unauthorised double glazed windows and unauthorised secondary staircase.
- 2) Replace the windows with a facsimile of the original windows fitted to the property, or;
- 3) Fit replacement windows which match the requirements approved by discharge of details application approved 26/2/2014 Ref: 2013/5964/L
- 4) Replace the secondary staircase with a facsimile of the original staircase or;
- 5) Fit a replacement staircase which match the requirements approved by discharge of details application approved 26/2/2014 Ref: 2013/5964/L

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **22 April 2014**, unless an appeal is made against it beforehand.


