ENFORCEMENT NOTICE

OF Flat 87, Marlborough Mansions Cannon Hill London NW6 1JT

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: Flat 87, Marlborough Mansions, Cannon Hill, London NW6 1JT as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: The unauthorised conversion of a residential flat within use class C3 to a House in Multiple Occupation within sui generis use class.

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last ten years
- b) The change of use to a House in Multiple Occupation (HMO) has resulted in the loss of a permanent self-contained home and the introduction of substandard and poor quality accommodation that detracts from the amenity of residential occupiers of the property, and to neighbouring residential occupiers contrary to policy CS5 (managing the impact of growth and development), DP9 (Student

housing, bedsits and other housing with shared facilities) and DP26 (managing the impact of development on occupiers and neighbours) of the Council's Local Development Framework 2010

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

WHAT YOU ARE REQUIRED TO DO

Within a period of two months of the Notice taking effect: the use of the flat as a House in Multiple Occupation within the sui generis use class shall cease and the internal partitions erected to create extra bedrooms shall be permanently removed.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 16 April 2014 unless an appeal is made against it beforehand.
