ENFORCEMENT NOTICE

OF 58 Doughty Street
London
WC1N 2JT

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND AFFECTED**

Land at: 58 Doughty Street, London WC1N 2JT

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without Planning Permission: the erection of a 2 metre high bamboo and twine screen subdividing the rear garden of a listed building.

4. **REASONS FOR ISSUING THIS NOTICE:**

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The screen detracts from the character of the listed building as a building of special architectural or historic interest by harming the historic relationship between the main house and the mews property, sub-dividing the original garden plot and negatively impacting visually on the setting of the listed building contrary to policies CS14 (promoting high quality places and conserving our

heritage) and DP25 (conserving Camden's heritage), of the Council's Local Development Framework 2010

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. **WHAT YOU ARE REQUIRED TO DO**

Within a period of **1 month** of the Notice taking effect: the bamboo and twine screen shall be permanently removed from the site.

6. **WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **18 March 2014** unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.
