1. **THIS IS A FORMAL NOTICE**, which is issued by the Council being the Local Planning Authority for the purposes of Section 38 of the above Act because it appears to them that there has been a contravention of Section 8 of the Act, in respect of the building within a conservation area described below. The Council considers it necessary to issue this notice for the reasons set out in paragraph 4 below.

2. THE LISTED BUILDING.

Land at: 47 Mornington Terrace, London NW1 7RT

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE CONTRAVENTION ALLEGED

Without listed building consent: erection of extension and replacement of a timber sash window on the rear elevation at first floor level.

4. REASONS FOR ISSUING THIS NOTICE

- a) The work outlined above has been carried out to this Grade (II) listed building without the benefit of Listed Building Consent
- The extension by reason of its poor quality, lack of detailed design and materials detracts from the special interest and appearance of the listed building and the character and appearance of the wider terrace of the wider streetscene. This is contrary to policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy; and policy DP25 (Conserving Camden's heritage) of the London Borough of Camden Development Policies Development Plan.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of **3 months** of the notice taking effect:

- 1. remove the extension and reinstate the sliding sash timber window to match original; and
- 2. any resulting damage to the building shall be made good

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 17 March 2014, unless an appeal is made against it beforehand.
