1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: 84 Parkway, London NW1 7AN

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: Unauthorised roof extension to dwelling (Class C3).

4. REASONS FOR ISSUING THIS NOTICE:

The roof extension by virtue of its height, bulk, mass, detailed design and materials, is detrimental to the character and appearance of the host property and the surrounding Camden Town conservation area. The development is therefore contrary to Policy CS14 (Promoting high quality places and conserving our heritage) of the Core Strategy and Policy DP24 (Securing high quality design) and DP25 (Heritage) of the Development Policies of the Camden Local Development Framework.

Council reference: EN12/0809

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of 6 calendar months of the notice taking effect:

- 1) Remove the unauthorised extension and restore the roof to its original profile; and
- 2) Make good any damage caused.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 13 March 2014 unless an appeal is made against it beforehand.
