Without listed building consent: the unauthorised tiling of the front step and entrance of 23 Fitzroy Square W1T 6EW

4. REASONS FOR ISSUING THIS NOTICE

- 1. The work outlined above has been carried out to this Grade II* listed building without the benefit of Listed Building Consent
- 2. The tiling of the front step and entrance area by virtue of the use of inappropriate materials results in demonstrable harm to the special interest of the grade II* listed building and terrace contrary to policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy; and policy DP25 (Conserving Camden's heritage) of the London Borough of Camden Development Policies Development Plan.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of three months of the Notice taking effect:

Completely remove the tiling to the front step and entrance and make good any damage to the building.

6. WHEN THIS NOTICE TAKES EFFECT
