# **TOWN AND COUNTRY PLANNING ACT 1990 (AS AMENDED)**

#### **ENFORCEMENT NOTICE**

OF 72-74 Parkway London NW1 7AH

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

#### 2. THE LAND AFFECTED

Land at: 72-74 Parkway London NW1 7AH

as shown, for the purposes of identification only, outlined in black on the attached plan.

# 3. THE BREACH OF PLANNING CONTROL ALLEGED

**Without Planning Permission:** The unauthorised increase in the height and depth of the first and second floor rear extension and increase in the depth and detailed design of the roof extension relative to planning permission ref: 2011/2373/P.

## 4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years
- b) The unauthorised rear extension, due to its scale is an excessively bulky and obtrusive feature which has a detrimental impact on the appearance of the host building and the character and appearance of the Conservation Area. The works are contrary to policies CS14 (Promoting high Quality Places and Conserving Our Heritage) of the London Borough of Camden Local Development Framework

Core Strategy; and DP24 (Securing High Quality Design) and DP25 (Conserving Camden's Heritage) and the London Borough of Camden Local Development Framework Development Policies.

- c) The unauthorised roof extension, due to its scale, bulk and detailed design is an incongruous and discordant feature which has a detrimental impact on the appearance of the building and the character and appearance of the Conservation Area. The works are contrary to policies CS14 (Promoting high Quality Places and Conserving Our Heritage) of the London Borough of Camden Local Development Framework Core Strategy; and DP24 (Securing High Quality Design) and DP25 (Conserving Camden's Heritage) and the London Borough of Camden Local Development Framework Development Policies.
- d) The unauthorised works at first and second floor level, by reason of their height and location, would cause an unacceptable reduction in access to sunlight and daylight to habitable rooms of neighbouring properties to the detriment of the amenity of occupiers. The works therefore fail to comply with Policy CS5 (Managing the impact of Growth and Development) of the London Borough of Camden Core Strategy and polices DP26 (Managing the impact of development on occupiers and neighbours) of the London Borough of Camden Local Development Framework Development Policies.
- e) The unauthorised works at first and second floor level, by reason of their height and location, would cause an unacceptable sense of enclosure to the detriment of the amenity of occupiers. As a result the works fail to comply with Policy CS5 (Managing the impact of Growth and Development) of the London Borough of Camden Core Strategy and polices DP26 (Managing the impact of development on occupiers and neighbours) of the London Borough of Camden Local Development Framework Development Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

#### 5. WHAT YOU ARE REQUIRED TO DO

Within **two months** of when the notice becomes effective the following steps are taken:

1. The first and second floor extension shall either be completely removed or implement the development in accordance with the approved scheme ref: 2011/2373/P as shown on the drawing ref: 1026E 003a and 1026E 004A.

2. The roof extension shall either be completely removed or implement the development in accordance with the planning permission ref: 2011/2373/P as shown on plans ref: 1026E 004A.

### 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **03 March 2014** unless an appeal is made against it beforehand.





#### WHAT HAPPENS IF YOU DO NOT APPEAL


