1. **THIS NOTICE** is served by the Council under section 187A of the above Act, because they consider that a conditions imposed on a grant of planning permission, relating to the land described in paragraph 2 below, have not been complied with. The Council consider that you should be required to comply with the conditions specified in this Notice. The Annex at the end of this notice contains important additional information.

**2. THE LAND TO WHICH THE NOTICE RELATES**

Land at: 21 Bromwich Avenue, London N6 6QH being land shown outlined in black on the attached plan.

**3. THE RELEVANT PLANNING PERMISSION**

The relevant Planning Permission to which this Notice relates is Planning Permission Ref: 2012/3634/P dated 28 November 2012.

A copy of the relevant Planning Permission is attached.

**4. THE BREACH OF CONDITION**

The following condition has not been complied with:

Condition 4 of permission 2012/3634/P has not been complied with and has been breached as the window in the side dormer is not fixed shut and is not of obscured glass.

**5. WHAT YOU ARE REQUIRED TO DO**

As the person responsible for the breach(es) of condition specified in Paragraph 4 of this Notice, you are required to comply with the stated conditions by taking the following steps:-

1. To ensure that the side dormer window is permanently obscure glazed and fixed shut up to a height of 1.7m above the floor of the room in which the windows are installed shall be permanently retained and maintained thereafter.

**Period for compliance:-**

**1 month** beginning with the day on which this notice is served on you.

**6. WHEN THIS NOTICE TAKES EFFECT.**

This notice takes effect immediately it is served on you or you receive it by postal delivery.

- 1 The development hereby permitted must be begun not later than the end of three



years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

- 2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

- 3 The development hereby permitted shall be carried out in accordance with the following approved plans: PC/GL 2012-2001 rev D01; 2012-2002 rev D01; 2012-2003 rev D01; 2012-2004 rev D03; 2012-2005 rev D03; 2012-2006 rev D03; 2012-2007 rev D03; 2012-2008 rev D03; 2012-2009 rev D01; 2012-2010 rev D01; 2012-2011 rev D02; 2012-2012 rev D02; 2012-2013 rev D01; 2012-2014 rev D01; Design and Access Statement rev D01 dated June 2012 prepared by Francis Birch Architect.

Reason: For the avoidance of doubt and in the interest of proper planning.

- 4 The side dormer window, as denoted on approved plan 2007-D03, shall be permanently obscure glazed and fixed shut up to a height of 1.7m above the floor of the room in which the windows are installed before occupation of the building hereby permitted and shall be permanently retained and maintained thereafter.

Reason: In order to prevent unreasonable overlooking of neighbouring premises in accordance with the requirements of policies CS1 (Distribution of growth) and CS5 (Managing the impact of growth and development) of the London Borough of Camden Local Development Framework Core Strategy and policy DP26 (Managing the impact of development on occupiers and neighbours) of the London Borough of Camden Local Development Framework Development Policies.

Informative(s):

- 1 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. - 2 Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to

Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. 3 Reasons for granting permission.
