### **ENFORCEMENT NOTICE**

OF Ground Floor Shop Unit 64 Churchway London NW1 1LT

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

## 2. THE LAND AFFECTED

Land at: Ground Floor Shop Unit, 64 Churchway, London NW1 1LT as shown, for the purposes of identification only, outlined in black on the attached plan.

## 3. THE BREACH OF PLANNING CONTROL ALLEGED

**Without Planning Permission:** The unauthorised creation of a self-contained flat at ground floor level.

## 4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The residential unit by virtue of its size and position provides substandard accommodation with inadequate natural light and insufficient floorspace to the detriment of the amenity of current and future residential occupiers, contrary to policies CS5 (Managing the impact of growth and development), CS6 (Providing quality homes) and CS14 (Promoting high quality places and conserving) of the London Borough of Camden Core Strategy Development Plan Document and policy DP26 (Managing the impact of developers on

occupiers and neighbours) of the London Borough of Camden Development Framework Development Policies.

c) The development contributes unacceptably to parking stress and congestion in the surrounding area, contrary to policies CS11 (Promoting sustainable and efficient travel) and CS19 (Delivering and monitoring the Core Strategy) of the London Borough of Camden Local Development Framework Core Strategy and policies DP18 (Parking standards and the availability of car parking) and DP19 (Managing the impact of parking) of the London Borough of Camden Local Development Framework Development Policies 2010.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

# 5. WHAT YOU ARE REQUIRED TO DO

- 1. Within a period of **one month** of the Notice taking effect, the use of the unit as a self-contained flat shall cease.
- 2. Remove any associated fixtures and fittings associated with the self-contained unit.

# 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **27 January 2014** unless an appeal is made against it beforehand.


You can appeal against this notice, but any appeal must be received or posted in time to be received by the Secretary of State before **27 January 2014**.
