ENFORCEMENT NOTICE

OF 25 South Hill Park

NW3 2ST

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND AFFECTED**

Land at: 25 South Hill Park, London NW3 2ST

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without Planning Permission: Unauthorised installation of glass balustrade around the lightwell on the front elevation of the host building.

4. **REASONS FOR ISSUING THIS NOTICE:**
 - a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.

 - b) The glass balustrade installed on the front elevation on the host building by reason of its design and location is considered to be an incongruous feature and results in the creation of clutter within the streetscene. As such it is considered to be detrimental to the character and appearance of the host building, the existing streetscene and the wider conservation area contrary to policy

Council reference: EN13/0846

CS14 of the Local Development Framework Core Strategy, and policies DP24 and DP25 of the Local Development Framework Development Plan Document 2010.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of **3 months** of the Notice taking effect:

1. Remove the glazed balustrade on the front elevation at ground floor level
2. Construct the development in accordance with the approved drawings of planning permission referenced 2008/0580/P dated 15/04/2008

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **16 January 2014** unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.
