#### **ENFORCEMENT NOTICE**

OF 102 Parkway London NW1 7AN

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

#### 2. THE LAND AFFECTED

Land at: 102 Parkway, London NW1 7AN

as shown, for the purposes of identification only, outlined in black on the attached plan.

#### 3. THE BREACH OF PLANNING CONTROL ALLEGED

**Without Planning Permission:** Change of use of the basement, first and second floors to sleeping accommodation which is occupied by the same person/people for periods of less than 90 days.

#### 4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last **4 years**.
- b) The change of use to short stay accommodation (Class C1) has resulted in the unacceptable loss of permanent residential housing (Class C3) contrary to objectives to maximise the supply of additional homes in the borough. As such, the proposal is contrary to Core Strategy Policy CS6 'Providing quality homes' and

Development Policy DP2 'Making full use of Camden's capacity for housing' of Camden's Local Development Framework.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

### 5. WHAT YOU ARE REQUIRED TO DO

Within a period of two months of the Notice taking effect:

The use of the basement, first and second floor of the property as sleeping accommodation which is occupied by the same person/people for periods of less than 90 days (short-term lets) shall permanently cease.

#### 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 9<sup>th</sup> January 2014 unless an appeal is made against it beforehand.

#### WHAT HAPPENS IF YOU DO NOT APPEAL


