ENFORCEMENT NOTICE

OF 62 Acton Street London WC1X 9NB

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: 62 Acton Street, London WC1X 9NB

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: The erection of a glazed link structure and a timber shed in the rear yard and the use of the shed as substandard residential accommodation.

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last four years
- b) The timber shed by virtue of its size, materials and design provides substandard accommodation with inadequate natural light and insufficient levels of insulation to the detriment of the amenity of current and future residential occupiers, contrary to policies CS5 (Managing the impact of growth and development), CS6 (Providing quality homes) and CS14 (Promoting high quality places and

conserving) of the London Borough of Camden Core Strategy Development Plan Document and policy DP26 (Managing the impact of developers on occupiers and neighbours) of the London Borough of Camden Development Framework Development Policies

c) The timber shed and glazed link structure by virtue of its size, bulk, mass, height and use of materials is considered to be detrimental to the character and appearance of the host building, the wider Bloomsbury conservation area and neighbouring listed buildings contrary to policies CS14 (Promoting high quality places), DP24 (Securing High Quality Design) and DP25 (Conserving Camden's Heritage), of the London Borough of Camden Local Development Framework Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of **three months** the timber shed and glazed link structure shall be permanently removed from site and the rear yard made good.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 20 December 2013 unless an appeal is made against it beforehand.

WHAT HAPPENS IF YOU DO NOT APPEAL


