**Without listed building consent**: The unauthorised installation of a metal grill door gate to the front entrance of 39 Great James Street, WC1N 3HB.

#### 4. REASONS FOR ISSUING THIS NOTICE

- a) The work outlined above has been carried out to this Grade II\* listed building without the benefit of Listed Building Consent
- The metal grill door by virtue of its detailed design, materials and location results in demonstrable harm to the special interest of the Grade II\* Listed building and terrace contrary to policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy; and policy DP25 (Conserving Camden's heritage) of the London Borough of Camden Development Policies Development Plan.

### 5. WHAT YOU ARE REQUIRED TO DO

Within a period of 1 month of the Notice taking effect:

Remove the metal grill door to the front entrance and all associated fixtures and fittings shall be removed and any damage to the building made good.

This notice takes effect on **16 December 2013**, unless an appeal is made against it beforehand.


